City of Caney City Ordinance No. 2009-03 Dumping, Depositing, Leaving Refuse, Garbage or Junk

An ordinance of the City of Caney City prohibiting the dumping, depositing, or leaving of refuse, garbage, rubbish, or junk on any right-of-way and/or public property, street or highway within the corporate limits of the City of Caney City and providing a penalty for violations of \$25 to \$200.

NOW THEREFORE:

Be it ordained by the City Council of the City of Cancy City, Texas:

SECTION 1

This entire ordinance is and shall be deemed an exercise of the police power of the State of Texas, and of the City of Caney City, for the public safety, comfort, convenience and protection of the City and citizens of said City; and all of the provisions hereof shall be construed for the accomplishment of that purpose.

SECTION 2

It shall be unlawful for any person, firm, or corporation to dump, deposit or leave any refuse, garbage, rubbish or junk on any right-of-way and/or public street or highway within the City of Caney City including the area outside the dumpster at the City dumpster station.

SECTION 3

The term "refuse" shall include garbage, rubbish, and all other decayable and nondecayable waste, including vegetable, animal, and fish carcasses, including open sewage from all public and private establishments and residences.

The term "garbage" shall include all decayable wastes, including vegetable, animal and fish offal and carcasses of such animals and fish, including open sewage and body wastes, industrial by-products, and shall include all such substances from all public and private establishments and from all residences.

The term "rubbish" shall include all worn out, worthless and discarded material, in general, including, but not limited to, old iron or other metal, glass, paper, cordage or other waste or discarded materials.

SECTION 4

Any person, firm or corporation violating this ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be fined in the sum of not less than Twenty-Five (\$25.00) nor more than Two-Hundred (\$200.00) dollars.

SECTION 5

Each and every provision, paragraph, sentence and clause of this ordinance has been separately considered and passed by the City Council of the City of Caney City, and each said provision, paragraph, sentence and clause would have been separately passed without any other provision, and if any provision, paragraph, sentence or clause hereof should be ineffective, invalid, or unconstitutional for any cause, it shall not impair or affect the remaining portion nor any other part thereof, but the valid portion shall be enforced in the same manner as if it had been passed alone.

SECTION 6

The City, by the adoption of this ordinance, hereby repeals all prior Ordinances relating to this subject matter.
