ORDINANCE NO. 21-83

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF CANEY CITY, HENDERSON COUNTY, TEXAS AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN THE CITY LIMITS, AND GRANTING TO SAID TERRITORY AND TO ALL FUTURE INHABITANTS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID FUTURE INHABITANTS BY ALL OF THE ACTS AND ORDINANCES OF THE SAID CITY.

WHEREAS, the City Council has considered annexation of the following described property, to-wit:

All that certain tract of land including only a portion of the State highway right-of-way of State Farm Road 3054 described more specifically as follows:

Beginning at a point where the present Caney City limit boundary line intersects the said State Farm Road 3054 on the East side of the city and thence along a line constituting the South boundary of the state owned right-of-way of said State Farm Road 3054 for a distance of one and one half mile to a point on the said South boundary line of said highway right-of-way one and one half mile East of the present city limit boundary.

Thence North from said point along a line parallel to the existing city limit boundary on said state highway of a distance of approximately one hundred feet to the North boundary line of said state highway right-of-way.

Thence West from said point along the North boundary line of said state highway State Farm Road 3054 for a distance of one and one half mile to a point where said state highway boundary line intersects the present city limit boundary line of Caney City.

Thence South along the present city limit boundary line for a distance of approximately one hundred to a point of beginning.

WHEREAS, said tract of land is contiguous and adjacent to the City of Caney City, Texas,

WHEREAS, after conducting hearings in consideration of such annexation as required by law, the City Council has voted to annex said territory to the City of Caney City, Texas:

to a point where said state highway boundary line intersects the present city limit boundary line of Caney City.

Thence South along the present city limit boundary line for a distance of approximately one hundred feet to a point of beginning.

be and the same is hereby annexed to the City of Caney City, Henderson County, Texas, and that the boundary limits of the City of Caney City, Texas, be and the same are hereby extended to include the above described territory within the city limits of the City of Caney City, Texas, and the same shall hereafter be included within the territorial limits of said city, and the said land the future inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Caney City, Texas, and shall be bound by the acts and ordinances of said city.

The City Clerk is hereby directed to file with the County Clerk of Caney City, Texas a certified copy of this ordinance.
