

AN ORDINANCE

AN ORDINANCE CALLING AN ELECTION FOR LOCAL SALES AND USE TAX, FIXING THE DATE OF ELECTION, DESIGNATING THE POLLING PLACES, APPOINTING PRESIDING JUDGE AND ASSISTANCE PRESIDING JUDGES, PROVIDING FOR NOTICE OF ELECTION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF CANEY CITY, TEXAS:

SECTION I. That an election be ordered in said Town on the question of the adoption of a local sales and use tax for the benefit of said Town in accordance with the provisions of House Bill No. 207, 60th Legislature, Regular Session, 1967,

SECTION II. That an election be ordered in said Town on the 15th day of November, 1969, which date is not less than thirty (30) nor more than ninety (90) days after the passage of this ordinance.

SECTION III. Said election shall be held at the St. Paul High School in said Town and C. A. Richardson is hereby appointed presiding judge and Vernon Wingham and Dorothy Henderson are hereby appointed alternate presiding judges for said election,

SECTION IV. Ballots of said election shall have written or printed thereon the following:

"FOR adoption of a one per cent (1%) local sales and use tax within the Town."

"AGAINST adoption of a one per cent (1%) local sales and use tax within the Town."

Each voter shall mark out one of the above propositions so that the one remaining shall indicate the way he wishes to vote.

The manner of holding said election shall be governed by the terms and provisions of the above mentioned House Bill No. 207,

with the law applicable to other municipal

SECTION IV. Ballots of said election shall have written or printed thereon the following:

"FOR adoption of a one per cent (1%) local sales and use tax within the Town."

"AGAINST adoption of a one per cent (1%) local sales and use tax within the Town."

Each voter shall mark out one of the above propositions so that the one remaining shall indicate the way he wishes to vote.

The manner of holding said election shall be governed by the terms and provisions of the above mentioned House Bill No. 207, and in accordance with the law applicable to other municipal elections.

SECTION V. In the event said 1% local sales and use tax is voted in the affirmative by a majority of the electorate of the Town of Caney City, Texas, then all said funds so received from said tax shall be designated and apportioned as follows:


- a. 100% (one hundred per cent) of said amounts received shall be designated and placed in the General Fund of said Town for its general use.

SECTION VI. Notice of said election shall be given by publishing a substantial copy of this ordinance on the same day of two successive weeks in a newspaper of general circulation published within said Town. The date of the first publication to be at least twenty one (21) days prior to the date set for said election. The City Secretary is hereby instructed to cause said notice to be so given.
